### Coal Market Implications

Like most other companies in the mining industry Centennial Coal (Centennial) has been reviewing its mining operations in response to the recent significant decrease in the US\$ price of export thermal coal over the past few months combined with the continuing high Australian dollar. The industry is suffering from record high production costs, largely a result of the resources boom-driven competition for scarce resources increasing wages and other input costs, but also including the impost of increased government processes and charges.

As a result of this review, locally, capital expenditure on the Newstan Extension and Northern Coal Services projects has been deferred, and regrettably Centennial has decided to place Mannering Mine on 'Care & Maintenance' commencing January 2013.

"The decision to place Mannering on 'Care & Maintenance' has not been taken lightly", said Centennial's Chief Operating Officer, Steve Bracken.

"Mannering has struggled to make a positive contribution in its own right not only through the lower coal price but a combination of difficult mining conditions and poor coal

quality has hindered the mines viability".

"In the current market, its losses can no longer be absorbed without negatively impacting the Group's overall performance", Steve Bracken continued.

"While we have redeployed the majority of our Mannering employees to other neighbouring sites across the Group, therefore minimising redundancies, regrettably this has been at the expense of contractors and particularly those at Newstan".

While on 'Care & Maintenance', Mannering will continue to meet safety and environmental regulations and will have a small care and maintenance crew on site, as well as a project team investigating different mine designs for the future. Mannering will be appropriately maintained to enable a reopening when market conditions improve.

"We will continue to progress the Newstan Extension and Northern Coal Service's development applications while also continuing to mine at Newstan in the areas we currently have consent." Steve Bracken concluded.

### Penalty Infringement Notice

Coal mined at Centennial's Mandalong Mine is either transported direct to Vales Point Power Station (operated by Delta Energy) by a 5km dedicated underground conveyor, or to the Cooranbong surface facility via a further underground conveyor system of length over 10km.

From the Cooranbong surface facility, located near Dora Creek, coal can then be transported to either Eraring Power Station (by a 1.5km overland conveyor) or to Centennial's Newstan Coal Handling and Preparation Plant and rail loader for export (via a dedicated private haul road).

No public roads are used.

For the 2011 reporting year, Mandalong exceeded its coal transportation limits to Eraring Power Station (overland conveyor) and to the Cooranbong Services site (underground conveyor). The limits that applied at that time were 2 million and 4 million tonnes per annum respectively.

These exceedances breached Mandalong's planning consent and have been reported to the NSW

Department of Planning and Infrastructure. As a result of exceeding these transportation limits, NSW Planning and Infrastructure has issued Mandalong with a Penalty Infringement Notice for both incidents.

Measures have been put in place to limit the possibility of these incidents reoccurring. These measures include, an already approved consent modification, which allows Mandalong to distribute 4 Mtpa of coal to either Newstan Colliery (via a dedicated haul road) or Eraring Power Station (via an overland Conveyor), a review and audit of Mandalong's production tonnages in the coming years and the Mine's compliance database. Additionally, Mandalong will also lodge a consent modification to increase the tonnage limits to the Cooranbong site (an underground conveyor system).

It should be noted that these breaches did not materially impact on other environmental outcomes (noise, dust etc).
